

VISA REQUIREMENTS

Citizens from the 169 'Visa-Free Countries' listed below are able to enter Indonesia without a visa for up to 30 days. A Visa-Free visit can be used for the following purposes:

1. Leisure and tourism
2. Family
3. Social
4. Art and Cultural or Representative office in Indonesia
5. Government visits
6. Giving a lecture or attending seminar
7. Attending a meeting held by Head office

The mandatory entry requirements for Visa-Free for short visits are:

1. Passport with minimum of 6 months validity from the date of entry to Indonesia
2. Onward or return tickets
3. No compulsory vaccinations

For travelers not included in the visa-free country list, you can apply for a Visa-on-Arrival at the airport. This is a short process. You will also need to adhere to the mandatory entry requirements that include: passport with minimum 6 months validity and return/in-transit plane tickets.

Passport holders from the following countries will need to apply for a visa permit from the Immigration Office in Indonesia: Afghanistan, Guinea, Israel, North Korea, Cameroon, Liberia, Nigeria, Somalia and Kosovo.
